

DOĞUŞ OTOMOTİV SERVİS VE TİCARET ANONİM ŞİRKETİ

DISCLOSURE STATEMENT ON THE PROCESSING OF PERSONAL DATA OF THE EMPLOYEES, INVESTORS, AND COMPANY OFFICIALS

In accordance with the Law No. 6698 on the Protection of Personal Data (“**Law**”), your personal data may be processed within the scope described below by Doğuş Otomotiv Servis ve Ticaret A.Ş. (“**Company**”), the data controller.

The Purpose of and the Legal Grounds for Processing Personal Data

Your collected personal data may be processed for the purposes set out below (“**Purposes**”) and within the scope of data processing terms and purposes set forth in Article 5 of the Law.

Based on the legal ground that it is clearly stipulated by the law and is mandatory for the data controller to fulfill its legal obligation;

- Your identity, contact, personal, and financial data may be processed to publicly disclose the statements of material information within the scope of the Communiqué on the Principles of Public Disclosure of Material Information and to disclose other matters that need to be disclosed to the public via the Public Disclosure Platform within the regulations of the Capital Markets Board of Turkey, *Borsa İstanbul A.Ş.* and *Merkezi Kayıt Kuruluşu A.Ş.* (Central Securities Depository of Turkey).
- Your identity, contact, and financial data may be processed to fulfill the requests of official institutions,
- Your identity, contact, and financial data may be processed for the purpose of providing information stipulated in the legislation to authorized institutions,
- Your identity, contact, personal, and financial data may be processed to ensure compliance with the storage obligations stipulated in the legislation,
- Your identity, contact, personal, and financial information may be processed to respond to the data subject’s applications in accordance with the legislation and to carry out the necessary procedures.

To Whom and For What Purposes the Processed Personal Data Can Be Transferred

Your collected personal data may be transferred to fulfill the requirements of information and document requests from legally authorized institutions and organizations within the scope of explicit stipulations in the laws and fulfilling our legal obligations, within the scope of the data processing conditions regulated in Article 5 of the Law, and in accordance with the rules regarding the transfer of personal data as specified in Article 8 of the Law.

Personal Data Collection Method

Your personal data is collected through physical and electronic forms, in-house systems, and internet systems for the abovementioned purposes.

Rights of the Data Subject Enumerated in Article 11 of the Law

We inform you that you have the following rights in accordance with Article 11 of the Law regarding your personal data:

- To know whether your personal data is processed or not,
- To request information if your personal data has been processed,
- To know the purpose of processing your personal data and whether they are used in accordance with its purpose,
- To know the third parties in the country or abroad to whom your personal data is transferred,
- To request the correction of your personal data if it has been incompletely or incorrectly processed.

You can submit your applications regarding your rights listed above to our Company by submitting a written petition, sending an e-mail to the Registered Electronic Mail (*Kayıtlı Elektronik Posta, KEP*) address registered on the website of our Company at www.dogusotomotiv.com.tr from your REM address, or sending an e-mail with your secure electronic signature or from your e-mail address to KisiselVerilerim@dogusotomotiv.com.tr. Depending on the nature of your request, your applications will be concluded free of charge as soon as possible or within thirty days at the latest. However, if the transaction requires an additional cost, you may be charged a fee according to the tariff to be determined by the Personal Data Protection Authority.
